This is a passionate team with a proven track record, and I am honored to take this next step in my leadership of the company. I am joined by the rest of the Arsenal team in a commitment to performance, execution, and safety, and we plan to continue to deliver as a partner of choice for our communities and our operational partners."

A graduate of the Advanced Management Program at Harvard, Mr. Farmer has spent his career at various Appalachian Basin operators, most recently Falcon Partners. He also has served on the board of Mountaineer Montessori and continues to stay involved in various philanthropic enterprises. Mr. Farmer has a Bachelor of Arts in Political Science and a Juris Doctorate degree.
